## VI. New Business

## General VCU Graduate School Admissions Requirements – GPA

The School of Business' Master's Program Committee requests that UGC considers revising the wording in the current policy regarding the undergraduate GPA requirement to make it official the fact that exemptions have been historically given for candidates who demonstrate clear improvements and qualifications that are not demonstrated in their undergraduate GPA.

## Proposed language:

Required grade point average: For admission to graduate study at VCU, the Graduate School prefers an undergraduate GPA of 3.0. Individual programs may have more lenient or stringent GPA standards. For students with earned graduate degrees from accredited institutions, the graduate GPA may be the primary basis for consideration.

## VII. Chair's Report

Thank you to the UGC members for all of your hard work this semester on the proposed changes to the general requirements of the Graduate School. At the last meeting on December 12, the UGC members will be voting on the proposed changes.

**General VCU Graduate School Admissions Requirements – Recommendation Letters & Statement of Intent**The Graduate School is working with the Provost Office and Office of Admissions to create a draft implementation plan for the proposed changes to the letters of recommendation and statement of intent requirements.

## **Proof of English Proficiency**

The English Language Program (ELP) housed in the Global Education Office has worked alongside the Graduate School and the Office of Admissions to revise the English Waiver requirements. This revision adds additional countries that qualify for a waiver as well as adjusts the Duolingo score to align with TOEL.

## **Special Actions**

Dawn Fields Crichlow has been actively working with Records and Registration to have course overloads and incomplete grades removed from the Special Action Form (SAF) and handled by that unit via their existing forms for these actions. Records and Registration is already doing these actions at the undergraduate level. More information will be forthcoming with a goal to launch this new process next semester. Additionally, Dawn is continuing discussions to see viable options for removing some actions from the SAF form.

## General VCU Graduate School Admissions Requirements – GPA

The Graduate School will do a review of peer and inspirational peer universities to see what language they are using in regard to GPA requirements for admission into graduate study. That data will be shared with the UGC members for discussion.
